TRANSPORTATION POLICY, FORM, & RELEASE

July 25, 2023

Hillsborough High School Rowing Club ("HHSRC") welcomes you and/or your rower to the program.¹ A successful rowing team requires its rowers to practice together so that they learn to act as a single unit. Once the rowing lineup is established, one rower's absence will affect the line-up's practice and can affect their success. Rowers that miss practices due to a lack of transportation and other reasons and their line-ups do not perform as well as those that attend regularly. Because our rowers succeed by attendance, HHSRC requires that rowers and their parents ensure that they have safe transportation available to them.

TRANSPORTATION POLICY

- To participate, you or your rower will have to meet at the Hillsborough High School Rowing Club Boathouse located at the Tampa River Center, Julian B. Lane Riverfront Park, 402 W. Laurel Street, Tampa, 33607, regatta locations, and at mandatory fundraising and volunteer events throughout the season.
- 2. Regular afterschool practice times are **Mondays** at **3:00 p.m.**, **Tuesdays**, **Thursdays**, and **Fridays** at **4:00 p.m.** and **Saturdays** at **7:30 a.m.**
- 3. With one exception, HHSRC does not provide transportation. Rowers and their parents are solely responsible for the rower's transportation to and from practices, most regattas, and other events.
- 4. On occasion, HHSRC or its coaches may change the location and time of practices for reasons such as coach unavailability, inaccessibility of the Boathouse or Julian B. Lane Riverfront Park, events on the river such as the Gasparilla flotilla, or weather. HHSRC and its coaches will make a good faith effort to provide sufficient notice to rowers to allow the rowers to change their transportation arrangements if necessary. Rowers and their parents are responsible for regularly checking GroupMe for scheduling announcements.
- 5. Freshmen and sophomores rowers often do not have transportation to the boathouse because their parents work and they are not yet able to drive.

Over the years, HHSRC parent volunteers and driving rowers carpool rowers to the boathouse in time for practice.

- 6. HHSRC does not control or supervise rowers' carpools.
- 7. To facilitate the process, HHSRC gathers information for those families that need transportation and those that can offer carpools. With the information, HHSRC parent volunteers help the rowers and their families connect with other families that can provide or need carpools. HHSRC rowers and their families can then contact the drivers and rowers and determine if the carpool is the right fit for the rower.
- 8. HHSRC does not vet carpool drivers or conduct an investigation into their driving history. The families are responsible for investigating the individual driver's record and/or skills, insurance, and to ensure that each family feels comfortable with the arrangement.
- 9. During the rowing season, carpools can be disrupted when the drivers are absent from school or are otherwise unable to attend practice. The students often arrange for back-up transportation on their own. When a carpool is disrupted and the HHSRC Board is notified that transportation is required, it will circulate a notice through SLACK to ask for volunteers to drive the rowers from Hillsborough High School to the Boathouse.
- 10. Backup transportation often relies on HHSRC's parent volunteers. In the past, some parent volunteers have repeatedly been available to transport rowers despite their own obligations or there are not enough volunteers available to provide back-up support. To ensure that the rowers' needs are met and there are always enough drivers, HHSRC asks that all parents participate in the carpool to the extent that they are able to do so.

	EXPRESS ASSUMPTION OF RISK AND RESPONSIBILITY		
13.	I acknowledge that driving is an inherently dangerous activity. I understand the risk associated with driving or riding in a carpool including serious injury or death.		

- 14. My or my minor child/rower's participation in a carpool is purely voluntary.
- 15. I acknowledge that HHSRC does not investigate the driving history of carpool drivers.
- 16. I acknowledge that HHSRC does not supervise carpools in any manner.
- 17. If either I or my minor child/rower will be driving, I hereby certify that I or my minor child/rower have valid driver's licenses and are not otherwise prohibited from driving.
- 18. If either I or my minor child/rower is driving, I certify that the vehicle to be driven is insured at or above the limits required by the State.
- 19. If either I or my minor child/rower is driving, I hereby certify that neither I nor my minor child/rower will drive under the influence of any drug, whether over-the-counter, prescription, or illicit, that can affect the ability to drive and/or put other rowers at risk of injury. I understand and agree that driving/carpooling under the influence of any drug, whether over-the-counter, prescription, or illicit, or alcohol, on the way to or from a HHSRC practice or event is a violation of the HHSRC Code of Conduct.
- 20. I certify that either I or my minor child/rower driver is capable of driving safely and in accordance with the laws of the State of Florida. I have no knowledge of or reason to have knowledge that my minor child/rower has driven or may drive negligently, recklessly or in a manner that could place passengers at risk of harm. I agree that if I learn that if I or my minor child/rower has driven negligent, recklessly, or in a manner that could place passengers at risk of harm, I will withdraw my or my minor child/rower's carpool.
- 21. I certify that I or my minor child/rower is informed of their obligations to notify HHSRC if they do not have a carpool. Further, I and my minor child/rower have discussed a family policy whether they are permitted to carpool with new drivers or drivers that have not been vetted by you.
- I, individually and on behalf of my minor child/rower, assume full responsibility for myself or my minor child for any bodily injury, accident, illness, paralysis, death, loss of personal property and expenses thereof as a result of any accident that may occur while I or my minor child participates in a carpool.

RELEASE

23. I release Hillsborough High School Rowing Club, its principals, directors, officers, agents, employees and volunteers, and their insurers, from any and all liability of any nature, including negligence or fault, for any and all injury (including death) or damage to me or my minor child and other other persons as a result of my or my minor child's participation in the carpool regardless of the cause.

INDEMNIFICATION

24. I, individually and on behalf of my minor child/rower when volunteering as a driver, agree to indemnify and hold harmless Hillsborough High School Rowing Club, its principals, directors, officers, agents, employees and volunteers, and their insurers, from any and all claims, actions, or suits arising from my negligence including all damages, settlements, costs, and attorney fees.
